## **Clonduff GAA Club Pre-AGM & Term Limits 2023**

The Clonduff GAA Club Annual General Meeting (AGM) takes place every year in November when ALL Executive positions are deemed vacant.

Date, time and venue are set at the Pre-AGM meeting in September.

Notification of AGM and Nomination Papers are distributed three weeks prior to AGM via Foireann email addresses or hand-delivered to those without email addresses.

Secretary's Report is posted on Website ([www.clonduffgac.net](http://www.clonduffgac.net)) 10 days prior to AGM.

Nomination Papers, together with Motions and Recommendations to be returned to Club Secretary one week before AGM

Nominations will appear on Website ([www.clonduffgac.net](http://www.clonduffgac.net)) one week prior to meeting.

Outgoing personnel may be nominated for their current or another position.

As previously agreed, (AGM 2011) and in accordance with National recommendations

- Chairperson to stand-down from post after completion of 5-year tenure.
- Chairperson may stand down prior to 5-year term end – Executive to be notified at Pre-AGM and preparations put in place for successor.
- Chairperson's position may be challenged by any fully-paid member of the Club during the 5-year term.

In accordance with National recommendations, if an Executive Officer's post remains unfilled, the incumbent may remain in situ until such time as a suitable replacement is selected and approved.

Clonduff GAA Club's Executive Committee shall meet at least once per month or more often as deemed necessary.

Sub Committees, chaired by a member of the Executive, are appointed by the Executive.

- Members outside the committee may be co-opted to sub committees with the approval of the Executive.
- In Clonduff GAA Club the Chairperson, Secretary and Treasurer are ex-officio members of all sub-committees and must be notified about sub-committee meetings.
- A simple report of sub-committee business must be recorded on the Pro Forma and a report made to Main Committee the following month.

- All sub-committees shall submit their annual report to club secretary for inclusion in and to complement the Secretary's report. To be with the Secretary one month before the AGM.
- Sub-committee terms expire at the following year's AGM.


Club's Financial Year to run from 1<sup>st</sup> October to 30<sup>th</sup> September in line with County Board recommendations.
